#### **TOURISM DEVELOPMENT (FORMS) REGULATIONS, 2002**

**Authority:** These Regulations were made on 19th September, 2002 by the Minister under

section 42 of the *Tourism Development Act*.

Commencement: 23rd September, 2002.

- **1.** These Regulations may be cited as the *Tourism Development* (Forms) Regulations, 2002.
- **2.** An application for an interim approval of a tourism project under section 3 of the Act must be in the Form A set out in the *Schedule*.
- 3. An interim approval granted under section 5(1)(a) of the Act must be in the Form B set out in the *Schedule*.
- **4.** An application for final approval of a tourism project under section 5 of the Act must be in the Form C set out in the *Schedule*.
- 5. The final approval of a tourism project granted under section 5(1)(b) of the Act must be in the Form D set out in the *Schedule*.
- 6. An application for a licence to operate a tourism product under sections 5(1)(c) and 10 of the Act must be in the Form E set out in the Schedule.
- **7.** A licence to operate a tourism product granted under section 10 of the Act must be in the Form F set out in the *Schedule*.

  - (a) goods that are imported, purchased from a bonded warehouse or locally manufactured for the construction, development and operation of the project as permitted under the Act;
  - (b) the provision of services that directly relate to the construction of the project.
